
JUDICIAL SYSTEM SENTIMENT

Methodology

This survey was conducted online within the U.S. by The Harris Poll from March 31st to April 2nd, 2023, among a nationally representative sample of 2,002 U.S. adults.



Nearly 8 in 10 agree, courts don't provide equal justice to all – and are most biased against those with prior offenses and undocumented immigrants



Q: Thinking about how the following would be treated in a judicial court hearing (e.g., state, Supreme Court, etc.), do you think the proceedings would be biased in any way? (Total n=2,002) Q: How much do you agree or disagree with the following statements? (Somewhat/strongly agree, Total n=2,002)

6 in 10 Americans say they or someone they know has been treated unfairly in a court of law, increasing to 8 in 10 Black Americans

Black Americans are more likely to note both unfair treatment in court and surprise at seeing someone like themselves on the judicial bench, pointing to inadequate representation (% agree)

"I or someone I know have been treated unfairly in a court of law"

Majorities of all political affiliations agree a more diverse bench would increase justice

8 in 10 Americans think the judicial system doesn't consider the human impact of its decisions, and 75% say our courts are taking away freedom

Across political parties, strong majorities feel our courts fail to understand their effects on people's lives and need fundamental change in order to deliver justice (% agree)

Majorities say cost, overburdened courts, political influence, and inconsistency are major problems that prevent equal justice under the law

People feel the courts must fix logistical and ethical issues to uphold "equal justice under the law"

When it comes to perceived problems, high agreement remains between political parties. Though gaps emerge on the severity of bias and diversity issues.

Nearly half of Americans would prefer an Al judge over a human one, and most are hopeful it can solve issues with bias and delays
